put some new windows in. Chairman said as long as she meets the design standards she can use darker siding with raw wood and the BD will need to approve it. There will be an addition to the rear of the building. All activity will be in the rear of the building for entering and exiting as well. She is creating additional parking spaces as well. She is asking if the board would like to see a gate for exiting. The board does not require it per Chairman Lacivita. He also stated for the public hearing she will need plans including security plan and interior and exterior plans and blueprints. Ms. Evenhouse also explained that she is required to have a vault. A Knox box will need to be installed. Ms. Evenhouse stated there will be a fence around the property and she would like to come off well water and connect to town water lines.

The document that she receives to be licensed will have to be given to the board. She will also need to provide storm water management plans. She needs to keep in touch with Jim Greenfield the historian because it is an historical building.
