IN THE MATTER OF ESTABLISHING AN INCREASE IN
TOWN WATER USER RATES PURSUANT TO AN INCREASE
BY THE CITY OF TROY FOR WATER PURCHASES

WHEREAS, the Town of North Greenbush contracts with the City of Troy for the purchase of drinking water that is supplied to all properties that have municipal water service; and,

WHEREAS, in accordance with that contract the City of Troy provided notice to the Town of a 5.82% rate increase on the sale of water to the Town beginning January 1, 2022; and,

WHEREAS, a 5.82% rate increase for an average sized family would amount to an estimated \$25 per year increase for water usage; and,

NOW THEREFORE BE IT RESOLVED, in accordance with Article X, Section 189-24 (A) of the Town Code, effective January 1, 2022 water rates for the Town of North Greenbush will be billed with a 5.82% increase for all water users in the Town.
