Town of North Greenbush Local Law No. 4 of the year 2024

A Local Law Increasing the Term of Office of the Town Supervisor, Town Clerk and Town Superintendent of Highways from Two Years to Four Years.

Be it enacted by the Town Board of the Town of North Greenbush; County of Rensselaer as follows:

Section 1. <u>STATUTORY AUTHORITY:</u> This Local Law is being adopted pursuant to the provisions of the Municipal Home Rule Law of the State of New York.

Section 2, INCREASE IN TERM OF OFFICE: The term of office of the elected Town Supervisor, Town Clerk and Town Superintendent of Highways shall be four years. Such four-year term shall commence as of the first day of January 2026 and shall apply to the person(s) elected to such offices at the biennial town election to be held in November of 2025 and to those elected thereafter, provided propositions submitted pursuant to Section Three below are approved.

Section 3, MANDATORY REFERENDUM: This Local Law is adopted subject to a mandatory referendum and shall be submitted for approval of the qualified voters of the Town of North Greenbush at the general town election to be held on November 5, 2024.

Propositions in the following form shall be included on the ballot at such 2024 general town election, and the increased terms of office shall not take effect unless such individual propositions are approved by a majority vote of the qualified voters voting thereon:

Proposition I

"Shall Local Law No.4 of 2024, entitled in part "A Local Law Increasing the Term of Office of the Town Supervisor from Two Years to Four Years" be approved?"

Proposition II

"Shall Local Law No. 4 of 2024, entitled in part "A Local Law Increasing the Term of Office of the Town Clerk from Two Years to Four Years" be approved?"

Proposition III

"Shall Local Law No. 4 of 2024, entitled in part "A Local Law Increasing the Term of Office of the Town Superintendent of Highways from Two Years to Four Years" be approved?"

Section 4. <u>SUPERSESSION</u>: this Local Law shall supersede Town Law, §24 relating to the term of office for the Town Supervisor, Town Clerk and/or Town Superintendent of Highways, after approval by the qualified voters.

Section 5. <u>EFFECTIVE DATE</u>: This Local Law shall become effective immediately upon being filed in the Office of the New York Secretary of State after approval by the qualified voters.
