Said property being located on NY-43 (w. Sand Lake Rd) 0.24 miles West of Lape Rd. Access to the proposed facility will originate from existing driveway off of NY-43 utilizing proposed 12' wide gravel driveway. In general, the installation will consist of the following: a 110' tall monopole (114' including 4' lightning rod), nine (9) antennas and related equipment to be mounted to the tower at a center-line height of 105', cellular and utility equipment at grade in a proposed 50'x50' fenced compound. The project also includes the installation of power and fiber utilities to service the facility.

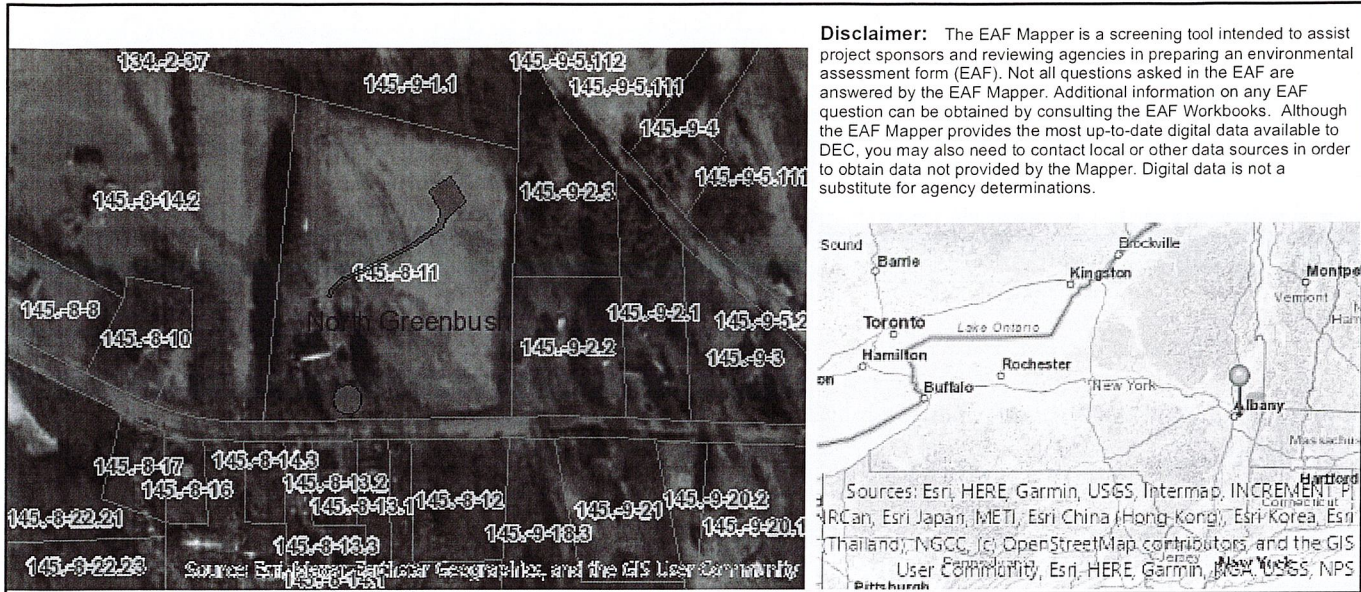
