PROGRESSIVE SWIM INSTRUCTOR

Qualifications:

- Must hold current American Red Cross Progressive Swim Instructor certificate as well as Basic Life Support for the Professional Rescuer

General Responsibilities: Implementation of the camp swim program

Specific Responsibilities:

- Assess swimming ability of each camper
- Plan and execute swim instruction of assigned campers
- Maintain order and discipline at all times
- Assist in the supervision of the campers in the swim area
- Participate in any training or orientation sessions
- Attend staff meetings as scheduled
- Daily inspection of lifesaving and teaching equipment
- Complete necessary American Red Cross paper work for swim Certificates
- Supervision of the campers in the water during free swim time
- To work as a lifeguard during free swim times
- Assume additional related duties as requested by the Camp Director or Waterfront Director

General Responsibilities: To plan, direct and supervise the day camp waterfront program and activities as well as supervise the public beach and staff.

Specific Responsibilities:

- Plan and schedule swim instruction program
- Supervise lifeguards and progressive swim instructors
- Schedule lifeguards for adequate supervision
- Assist with program supply inventory
- Conduct mid term and final evaluation of waterfront personnel
- Prepare end of program report
- Schedule and attend summer camp staff meetings
- Maintain daily log of activities and/or problems
- Verify waterfront time-sheets
- Maintain order and discipline at all times
- Act as liaison with the American Red Cross
- Execute buddy checks in appropriate time intervals
- Act as lifeguard or progressive swim instructor when needed
